All of a sudden, you are in a rush. You did nothing that I am aware of proactively in the wasted first month of this year.

It was not me who has caused any delay.

Joe told me that this would be handled after New Years. Nothing happened in January. Phone calls went unanswered and emails to Joe had never been answered. As stated in an email yesterday, the day you saw me at Catholic Charities, I had a set of references for counseling but deferred selection of facility to YOU. It has been around 4+ hours since my last email and I am guessing that I may have your grudging focus now. You perceive yourself as blameless, impeccable morals, driven by the best and purest of human motivations and intent in regards to your tireless care of Dad. For the most part, I concur. The one issue seems to be that you enjoy being the one and only. Unfortunately, four point five months before your tenth birthday, I showed up, forever ruining your plans (not even considering Number 3 son whom you have safely tucked away) for being Dad's Number 1 *and only*.

In recent years, you encountered a sudden physical loss of family. I say physical because the emotional roots of what caused this event go back many more years. Sorry for bringing up the painful but, your family left you enmasse. No second looks back, no stragglers, no surprise as well. It was a move that took years of preparation as well as great patience to pull off. I am not an expert in the politics of your family. I can only go by personal observation as well as insider knowledge as provided to me by at least one member of that family.

If people in this stupid family would ever find it worth their time to just consider things family says without anger it would be a freaking revelation. 7:05pm"yeah. I dunno. U all should support each other. I freaking hate saying negative things about people."

Fast forward a week: Dec 7 2:00pm"When did my dad tell that he talked w me? Also, what did he say about it?" I recall relating the timeline, talking to Dad at Omega who told me that you had spoken to David. He replied:

I honestly didn't even listen. I dont want any part in whether he talks to jennifer, u smearing his name n ruining his "business", etc. this is the reason he talked to me - to get me on his side. Not because we Havent spoken in 2 years. So Damn selfish." The quotes around business are from DHM. Further replies to me:

Dec 7 2:25pm"Yeah well I wasnt wrong when I decided to distance myself. U know, the more attention u give him the more he likes it. Stop fueling the fire" End of DHM sms.

I agree. I am tired of playing the Blame Game.

Perhaps I was a little loud on Dad's birthday - so were you.

Perhaps I could have planned it better. Not easily done as there was never any planit was an event that evolved.

Whether you choose to believe me regarding Dan and Marvin does not in any way make their individual appeals to me any less true.

You were and, at other times, have been out of control. You could not stop your repetitive behavior if your life depended on it. Classic Borderline Personality disorder traits - I have worked in very close proximity to two people diagnosed with BPD. It is nothing to be ashamed of and people afflicted with it lead totally normal lives when they are properly treated for it.

One of the girls I know is quite intelligent, holding a job with significant responsibility. The other is sweet and intelligent and a good mom when she is under treatment and, when she has her period, she sometimes misses a dose or two of Wellbutrin and becomes a monster that terrorizes her kids and is impossible to communicate with - like talking to a human broken record. That is a trait I observed in you while you were hyperventilating, with bulging eyes, bright red face, repeating and repeating some phrase, unable to even comment or properly respond to me.
